- Cylinders on plow truck are leaking; the snap rings are broken.
- Getting a dumpster to get rid of all the excess materials that people have dumped by the WWTP.

- The attorney is waiting for MSA for a map for the Sexauer and Schmidt/Small Town annexation. Should have everything for next month's meeting.
