CALL TO ORDER: Meeting called to order at 6:42p.m. with President Jon Hohlfeld presiding.

MINUTES: Seth Hemmersbach motioned, and Penny Stock seconded to approve the 8/12/2025 and 8/26/2025 special minutes. The minutes were approved as submitted. Motion carried.

ISSUES FROM THE PUBLIC: Rob Uploff and Matt Castillo presented the water and wastewater study. A lot of information to digest.

TREASURER REPORT: The August Treasurer's Report was reviewed. Seth Hemmersbach motioned and Bob Nielsen seconded to approve the report as submitted. Motion carried.

<u>VOUCHERS</u>: The vouchers were reviewed. Linda Young motioned, and Penny Stock seconded to approve payment of ACH's and checks #5618-5625 in the amount of \$13,516.66. Motion carried.

OLD BUSINESS:

• Delinquent water/sewer bills. Twenty-four 10-day notices were mailed to residents and Eleven 24-hour notices were hung on doors.

NEW BUSINESS:

• An increase in sewer rates was discussed. Linda Young motioned and Seth Hemmersbach seconded to increase the sewer usage and sewer service charge by 8% beginning January 1, 2026. This will increase the sewer usage from \$8.95/1000 gallons used to \$9.67/1000 gallon used. The service charge will increase from \$11.45 to \$12.37. This will be noted on the water/sewer bills that will be due in October.

<u>ADJOURNMENT</u>: Seth Hemmersbach motioned, and Linda Young seconded to adjourn the meeting. Meeting adjourned at 8:20 p.m. Motion carried.
