SPARTA AREA AMBULANCE: Bob Hess had handouts on the history and inventory of an ambulance with a cost over \$324,000. They contract with 15 municipalities with 37 employees. The 2024 budget for payroll is \$1.4 million. Medicare and many insurance companies have established set rates for ambulance services. Rockland has a population of 754 with \$10 per capita=\$7540. Discussed adding an Ambulance Protection fee to the water bill. Randy Rowell motioned, and Bob Rueckheim seconded to pay the ambulance invoice. Motioned carried.

MAINTENANCE DEPT.: Isaac was not present to address any issues. Rockland Flooring was discussed. Motion made by Randy Rowell and seconded by Derek Millin to open a sewer savings account recommended by the DNR. Motion carried.

LOCAL ORDINANCE: No discussion

<u>NEW BUSINESS</u>: Alex from TDS would like to help sponsor an event. Willing to cover \$1500 towards fireworks. Stephanie indicated that Terry is good with 6/29/24 to facilitate the fireworks. She is awaiting the pricing for the fireworks.

BB Fire Department car show is at Gaylord Park on 5/11/24. Requesting Class B Fermented Malt Beverage License. Derek Millin motioned, and Randy Rowell seconded to approve the license. Motion carried.

TIF PROJECTS: Some of the projects discussed that could be completed with TIF funds are cameras at Gaylord Park and Sewer Plant. Jon received quotes from Choice Security for \$6968 with a 5-year subscription. Jon to find out about the 5-year subscription. Digital Bay gave a quote of \$5955 with no remote access. Jon will get more information. Bob will get quotes on the walking path and parking lot for Gaylord Park. A question was asked about what percentage of the generator will TIF pay for. Stephanie/Mel will call the State with TIF questions.

<u>VILLAGE HALL:</u> Mel received a quote from Western Wisconsin Electric of \$300 to relocate the outlet in the office to the North wall. Derek Millin motioned, and Bob Rueckheim seconded to have them go ahead with the relocation. Motion carried. Bob Nielsen will get a quote for power washing the water tower.
