Meeting called to order at 5:40 p.m. with President Jon Hohlfeld presiding.

BANGOR POLICE DEPT. PROPOSAL: The Village of Rockland board trustees met with the Bangor Police Chief Scott Alo and Bangor Village Administrator/Clerk Jeri Wittmerhaus to discuss the possibility of Rockland contracting with Bangor for police services. The Village of Bangor presented a proposal to the Village of Rockland with the following conditions: Scheduled hours per year = 7,608 (approximate), Five (5) year Agreement/Contract with projected 9% yearly increases: FY2022 - \$90,000 (+\$5,000 to outfit new officer – actual cost is \$7,000) FY 2023 - \$98,100, FY 2024 - \$106,929, FY 2025 - \$116,553, FY 2026 - \$127,041. The FY (fiscal year) 2022 total budget of the Bangor Police Dept. is \$297,499.28. \$90,000 equals 30.25% of Bangor Police Dept.'s fiscal year 2022 budget. There were other stipulations as well with regards to court fees for tickets, etc. that would need to be discussed. The Village of Rockland board discussed the proposal and made a unanimous decision at this time that this is not in Rockland's current budget.

SLUDGE TRUCK: This was tabled.

ADJOURNMENT: Bob Rueckheim motioned and Randy Rowell seconded to adjourn. Motion carried. Meeting adjourned at 7:20 p.m.
